## **WELCOME AND REVIEW AND APPROVAL OF THE APRIL 2010 MEETING SUMMARY – STEVE KERMAN**

CNAC Vice-Chair, Steve Kerman, began the meeting at 7 pm by having the committee members and Port staff introduce themselves.

Steve asked the committee for edits to the April 2010 meeting summary. There being none, a motion was made to accept the April 2010 meeting summary as written. The motion was seconded and passed.

## **NEIGHBORHOOD REPORTS, AIRPORT NOISE REPORT, OTHER NEWS – KELLY SWEENEY**

With the reinvigoration of the neighborhood outreach program, 27 neighborhoods were visited since the April CNAC meeting; bringing the total to 70 visited since the beginning of 2008. This brings the number of people contacted to 1,740 and approximately 552 of those were on the Vancouver side of the river

Kelly said he will continue to get the message out regarding the NREX project. He was able to get a story in the Wilshire/Beaumont neighborhood newsletter in April that is entitled “Heads Up” and address the resumption of the work on the north runway.

Kelly will be providing a calendar of upcoming meetings. He again asked for members attending neighborhood meetings to notify Jason Schwartz, chair Maryhelen Kincaid and him so he can track attendance.

Chief concerns being heard in the neighborhoods are regarding the F15 flights, the cargo feeder noise and NREX work. Noise complaints in the Vancouver area are concerning trains.

Other news; Sean Loughran, from the Port of Portland reported the south runway closure for the weekend of May 15 for repairs and north runway closes on Monday for the summer.

## **NOISE MANAGEMENT OVERVIEW – NORTHEAST PORTLAND – NOISE TEAM**

Gregg Maxwell gave an overview of operations at PDX. His talk included information regarding how arrivals/departures will impact the Northeast Portland community.

Gregg gave a briefing on NREX (North Runway Extension Project) and the expected operations changes in 2010.

## **NOISE MANAGEMENT UPDATES AND REPORTS – JASON SCHWARTZ**

Jason Schwartz spoke to the efforts by the Noise office to increase outreach in area neighborhoods.

Jason revisited the topic of the SharePoint database saying it is being built and will be released in two phases. The first phase will be an internal site that includes the CNAC roster which will provide Port staff with information such as member term expiration dates. Other documents will be placed in a SharePoint library for use by the Noise team.

The second phase will be a database for outreach tracking. There will also be an events calendar as provided by Kelly.

Jason invited committee members to the upcoming public open house in the new Port headquarters building on June 5 from 11:00 am – 3:00 pm. He also invited members to call the Noise office if they would like an individual tour.

Koto Kishida asked if the 65 DNL work group was discussed with PAG. Vicki Thompson responded by saying it was not. Jason explained that after discussion with the PAG and Noise Working Group (which included input from Maryhelen), it was decided that the work group will continue, as a separate committee from CNAC.
