- [B] Terminal Rate Types are as follows:**
 Type I - **ATC**: Ticket Counters, **ATI**: Self-Service Kiosks
 Type II - **ADA**: Departure Areas (Holdrooms), **APL**: Passenger Lounges, **ATO**: Ticket Offices, **ATM**: CU Ticket Offices
 Type III - **AUA**: Upper Level Area, **ABC**: Joint Bag Claim
 Type IV - **ASO**: Baggage Service Offices, **AOM**: Operations and Maintenance (lower level space)
 Type V - **AIA**: International Arrival Facility, **AOB**: Baggage Make Up
 Type VI - **AIB**: Inbound Baggage Road (Enclosed Baggage Road)
- [C]** Ground Loading Areas include Concourse A (12 parking positions) and Concourse B (4 parking positions).
- [D]** All airlines are invoiced by the Baggage Consortium.
