

EXECUTIVE DIRECTOR'S REPORT TO THE PORT OF PORTLAND COMMISSION FOR SEPTEMBER 2018

SAFETY REPORT

Port of Portland August 2018 safety performance resulted in a lower frequency of injuries and claims compared to August 2017. There were four total reported injuries in August 2018, none of which resulted in either a claim or an Occupational Safety and Health Administration recordable case.




Worker was throwing wire line over pipeline and felt a strain in the right shoulder.


Three non-recordable injury incidents:

<u>Passengers</u>

Portland International Airport (PDX) August 2018 passenger volumes increased 3.5 percent compared to August 2017. Seat capacity increased 5.1 percent, with the load factor falling 1.3 points to 86.1.

From June through August, PDX served a record 5.9 million travelers; an increase of almost 236,000 travelers, which equates to about 2,565 more passengers per day.

Concessions Revenue

The reported 8.8 percent, or \$141,000, rent increase over last year is 5.3 percentage points above the 3.5 percent passenger increase on the month, and includes a net increase of \$3,000 in rents produced from facilities not open both years. The August rent increase is attributed predominantly to the casual dining category, which increased 22.2 percent over last year on the month.

Rental Car Revenue

Rental car operations reflect a 4.0 percent, or \$232,000, rent increase year-to-date over last year, against a year-to-date enplanement increase of 4.1 percent through August. This performance is reflective of last year's activity in August associated with the solar eclipse.

Parking Revenue by Lot

Public parking revenue increased 15.7 percent over August 2017, and 13.5 percent year-to-date. Rate increases to the long-term, economy, and valet products account for much of the increase over 2017.

Parking transactions increased 2.4 percent compared to August 2017, with increased transactions in all public parking products. Transactions have been relatively flat during the last fiscal year, and the 2.4 percent increase reflects a second month of increases with July transactions up 0.6 percent. The increase in transactions represents more customers parking in the public products over Fiscal Year 2017 year-to-date.

Ground Transportation

August 2018 was the second full month with the new per/trip fee rates in place (effective June 11, 2018). Overall revenue increased 67.1 percent to \$806,645 in August 2018, compared to \$482,852 in August 2017. Transportation Network Company (TNC) revenue for August 2018 was \$607,512.

Roads improved by the project also proved less structurally sound than design testing had indicated, triggering construction of a more robust roadway.



Operating income before depreciation (OIBD) is \$2.2M. Operating revenues are \$6.1M less than budget primarily due to the timing of land sales. Excluding land sales, operating revenues are up \$0.8M from the budget of \$10.4M. Operating expenses before depreciation are \$7.0M less than budget due to the timing of land sales. Excluding cost of property sold, operating expenses before depreciation are \$1.7M less than the budget of \$10.7M. Financial results for each division are detailed below.

Marine

Volumes

Autos – Volumes are 14% less than forecast (12% < prior year) primarily due to AWC's inventory control of Hyundai imports and a leveling-off of Ford exports due to lower sales in China.

Grain Bulk – Tonnage is 18% less than forecast (5% < prior year) due to increased competition along the Columbia River.

Mineral Bulk – Tonnage is up 5% from forecast as Canpotex continues to route more potash through T-5 and market demand overseas for soda ash remains strong.

Terminal 6 Container Facility:


- Railway Shuttle BNSF moved a record of 4,827 containers in August to/from the railyard; moves are up 16% from forecast.
- Vessel Operations Four Swire ship calls YTD account for 828 short tons of lumber and 111 breakbulk units (nearly all Daimler trucks).
- 53' Container Service The terminal received 437 53-foot containers (874 TEUs) manufactured by China-based Singamas to be loaded on Union Pacific rail cars. This will likely be the last service for calendar year 2018.

Operating Financial Results:

Operating revenues are \$539K > budget due to revenues from the delivery of 53-foot containers at T-6 (\$257K), higher than forecast rail moves (\$193K > budget), and higher potash revenues \$(62K > budget).

Operating expenses before depreciation are \$485K less than budget, with the largest variances listed below:

- Contract, Professional, and Consulting Services are \$367K < budget primarily due to lower business development
 outside services expenses (\$158K < budget), lower LOADMAX system maintenance expenses for monitoring
 Columbia River depth (\$24K < budget), timing of nondestructive (NDT) crane testing at T-6 (\$50K < budget), and
 lower Harbor superintendent costs at T-6 (\$35K < budget).
- Utilities are \$186K < budget do to timing of billings for electricity and stormwater (\$70K and \$110K < budget, respectively).




Industrial Development

Operating revenues excluding land sales are \$92K less than budget primarily due to the timing of reimbursements from Tidewater and Shaver for mooring barges in the Columbia River. Including land sales, operating revenues are \$7.0M less than budget due to timing of the TRIP Lot 3 sale to FedEx, which has been extended to October 30th.

Operating expenses excluding cost of property sold and depreciation are \$335K less than budget, with the largest variances listed below:

- Contract, Professional, and Consulting Services are \$251K < budget due to timing of payments to the Oregon
 Department of State Lands for the Tidewater and Shaver subleases (\$101K < budget) and land use and development
 consulting (\$82K).
- Travel and Management Expenses are \$51K < budget.
- Interdepartmental transfers are \$52K < budget.





Navigation

Operating revenues are \$182K more than budget primarily due to higher operating expenses, primarily labor. Higher operating expenses translate into higher reimbursement revenues from the U.S. Army Corps of Engineers (USACE).

Operating expenses before depreciation for Navigation in total are in line with budget. However, expenses for the USACE reimbursement contract are \$107K > budget due to increased overtime from three weekend dredging days. Expenses not reimbursed by the USACE are \$117K < budget primarily due to lower expensed fixed assets.




Port of Portland Operating & Financial Results FY 2018-19 through August 31, 2018

General Aviation

Operating revenues are \$87k greater than budget mostly due to higher rent revenues (\$28K > budget), fuel flowage fees (\$22K > budget), and concessions revenues (\$18K > budget).

Operating expenses are \$298K less than budget due to timing of HIO master plan consulting costs (\$92K < budget), lower equipment repairs (\$81K < budget), and lower personnel services due to position vacancies (\$37K < budget).




Support Services

The costs for the support services divisions are either directly charged out (i.e. Engineering) or allocated to the operating divisions. Support services includes the divisions listed below.

- Administration & Equity (Equity, Human Resources, IT and Administrative Services)
- Executive Admin
- Financial, Audit & Risk Services
- Legal
- Project Delivery and Safety (Engineering, Project Portfolio Office and Safety)
- Public Affairs

Operating expenses before depreciation are \$593K under budget, with the largest variances listed below:

- Personnel services are \$430K < budget due to position vacancies (~60% of vacancies in Engineering; new positions not yet filled).
- Materials & services are \$475K < budget due to timing of IT expenses primarily for Cisco hardware maintenance (\$130K < budget); Project Delivery & Safety expenses mostly for ProMIS implementation (\$169K < budget); Human Resources expenses for software subscription fees and the recognition program (\$127K < budget); and Administrative Services expenses primarily for the disparity study (\$57K < budget).
- Interdepartmental Transfers & Expense Allocations are \$312K > budget due to fewer Engineering and IT hours being charged to capital projects.




Portland International Airport

Activity

Through August, PDX has served more than 4.0 million passengers, up about 4% from the prior year. At almost 2.4 million pounds, landed weight is up almost 6% from the prior year.

Passengers and landed weight are key drivers of revenues and expenses for the airport. Strong demand for air travel results in air carriers increasing seat capacity and adding flights.




PDX Airline Cost Center (ACC)

ACC revenues are up \$609K from budget primarily due to higher food and beverage and retail concessions sales (\$288K) and common use rentals (\$252K).

ACC expenses are down \$786K from budget, with the largest variances listed below:

- Materials and services are \$969K < budget primarily due to lower materials and services for the Fire Department (down \$338K), timing of expenses for the new terminal customer services contract (down \$198K), lower custodial and grease hauling expenses for concessionaires (down \$87K), timing of concessions marketing support reimbursements (down \$68K), and environmental expenses (down \$147K).
- Interdepartmental transfers and allocated expenses are \$175K > budget due to fewer maintenance hours being charged to the terminal building.



PDX Port Cost Center (PCC)

PCC revenues are up approximately \$1.7M from budget primarily due to higher parking revenues (up \$674K), rental car concessions (up \$272K), and transportation network company trips (Uber, Lyft; up \$500K).

PCC expenses are \$542K less than budget due to timing of materials and services expenses, including environmental expenses (down \$106K), stormwater expenses (down \$83K), ground transportation management fees (down \$89K), parking credit card fees (down \$65K), and the SW Quad development study (down \$60K).
