

EXECUTIVE DIRECTOR'S REPORT TO THE PORT OF PORTLAND COMMISSION FOR FEBRUARY 2025

OCCUPATIONAL SAFETY & HEALTH REPORT

Port of Portland January 2025 safety performance resulted in fewer Workers' Compensation claims reported as compared to last year. There was one reported injury incident that resulted in a workers' compensation claim. There were also five property damage cases and five nearmiss incidents reported. All incidents were analyzed with actions defined to prevent recurrence, which are being tracked to completion.

Monthly Report of Safety Incidents

Aviation Operations

One near-miss incident:

 A Parking Control Representative (PCR) issued a written warning to a driver on the upper roadway. After placing the warning on the driver's windshield, the driver got out of the vehicle, grabbed the warning, approached the PCR from behind and attempted to put the ticket in the chest pocket of the PCR's vest. Police responded to the event.

One non-recordable incident:

• A firefighter was on wildland fire deployment. While exiting the cab of the fire engine, the firefighter slipped and fell onto his knee, suffering a contusion. The injured knee was checked by a doctor. Use three points of contact when exiting large vehicles.

Headquarters

One near-miss incident:

Two non-employees showed up unscheduled to the headquarters reception area. They
were hostile to reception staff while asking to see representatives from Risk
Management. Staff phoned for support and safety responded to assist in deescalating
the situation and arrange a meeting with Risk Management.

Rental Car Center

Two near-miss incidents:

- A PDX employee witnessed improper pedestrian crossing by a tenant. The tenant crossed the north lower roadway to catch a shuttle, but was not in a designated crosswalk. Always use pedestrian crosswalks and look before leaving the curb.
- It was discovered that the bistro chairs in the fourth floor break area had loose chair legs causing instability. It was found that the chair legs were not fully attached. The chairs were repaired and put on an inspection cycle.


Navigation

One near-miss incident:

• It was discovered during inspections that a welding gas cylinder was actively leaking from a small hole in the bottom of the cylinder. The cylinder was taken out of service.


Five property damage incidents:

- During pre-use checks, the boom length indicator cable had separated and broke on the crane boom. A work order for repair was created.
- A mobile staircase was found to be damaged at the Navigation base. Investigation suggests it may have been backed into by a forklift. This staircase is unrepairable and a new one was ordered.
- An All-Terrain Vehicle (ATV) that the survey team uses and stores on Hump Island was found to have parts missing (stolen) off the equipment. Repairs were scheduled to be made and the ATV security process refined.
- A rollup door at the Navigation base was damaged when a forklift mast struck it. The
 door was repaired and the forklift operator retrained on maintaining clearance with
 overhead objects.
- A compressed gas tank carrier and bottle was found to be damaged. The unit and bottle were removed from service.




Total Departing Seats Available & Enplaned Passengers




Concessions Revenue




Parking Revenue

CAPITAL GRANTS

Portland International Airport

Staff submitted a reimbursement request to the Federal Aviation Administration (FAA) for PDX 91 – South Runway PCC Panel/Joint Rehab in the amount of \$127,059.90, covering the September 1, 2023-December 1, 2023 period. This grant has been officially closed by the FAA, for total grant funding amount of \$1,298,400 (Agreement No. 03-41-0048-091).

Staff submitted a reimbursement request to the Federal Bureau of Investigation (FBI) for the PDX Regional Drug Organized Crime Task Force program in the amount of \$5,092.65, covering the October-December 2024 work period (Agreement No. 281C-PD-C2079840).

Staff submitted a reimbursement request to the FBI for the Joint Terrorism Task Force program in the amount of \$354.36, covering the December 2024 work period (Agreement No. 66F-PD-A46560-MOU).

Staff submitted a reimbursement request to TriMet for the Law Enforcement Officer program in the amount of \$20,509.70, covering the December 2024 work period (Agreement No. GS150820LG)

Staff submitted a reimbursement request to the Office of the State Fire Marshal for the Microwave Tower Fire Mobilization Response in the amount of \$28,850.04 (IGA No. 20200-IRMCWV-24).

The Hillsboro Runway 13R/31L and Runway Safety Area Improvements project was below the project DBE goal of 10%. This shortfall was driven by reduced scopes of work that were at least partially contained in DBE subcontractor contracts. The first area of scope reduction was in the need for imported topsoil. Topsoil material for the project was to be a combination of imported material and usage of onsite soil stockpiles generated by previous projects. Once earthwork began and the stockpiles began to be utilized it was discovered that they contained material that was unsuitable to be used as topsoil per the project specifications. To address the issue the contractor opted to bring a trommel (a large machine that screens material) onsite to process the stockpile material, which generated a high volume of quality topsoil and negated the need to import material. The volume of generated material was paid under the imported topsoil bid item after negotiation with the contractor. However, the reduced need for actual imported material impacted the DBE's subcontract as that import was their scope of work. The second area of scope reduction was a reduced need for sediment fencing on the project. The City of Hillsboro inspector determined that certain areas that called for sediment fence were located on portions of the airfield that did not pose a risk of erosion driven sediment from entering the City's stormwater system and as such could be eliminated from the project.
