OCCUPATIONAL SAFETY & HEALTH REPORT

Port of Portland August 2023 safety performance resulted in the same frequency of Workers' Compensation claims reported as compared to last year. There were four reported injury incidents in August 2023, of which two resulted in workers' compensation claims and one was an Occupational Safety and Health Administration recordable incident. There were also six near-miss and one property damage incidents reported. All incidents were analyzed with actions defined to prevent recurrence, which are being tracked to completion.

Monthly Report of Safety Incidents

Aviation Maintenance

Two first aid only incidents:

- An employee was pulling a heavy tire from an elevated rack at the vehicle shop and lost control of the tire, causing it to fall and strike their knee, resulting in a contusion. Analysis revealed there is room to store heavy tires near the floor in the power lifting zone.
- An employee struck their hand on a shelf while retrieving a paper ream from a box. The paper ream was stuck in the box and their hand slipped, striking a nearby shelf which caused a minor cut.

Two near-miss incidents:

- A maintenance employee was unloading granular deicer from a flatbed truck with a forklift. The truck was parked between the dry chemical storage barn and tire shop. While conducting the task, the forklift operator sounded the horn as they came around the corner of the barn and saw a vehicle shop employee transiting a vehicle towards them at a high rate of speed. The vehicle shop employee slammed on the brakes to avoid collision. Work zone controls may be employed as a result of the analysis.
- While conducting preventive maintenance on the shop air compressor, an employee recognized that the pressure safety valve on the equipment was higher than the tank's maximum pressure. An appropriately rated pressure safety valve was installed that will eliminate the risk of rapid disassembly of the air compressor tank.

Marine Facility Maintenance

One recordable incident:

- An employee was driving a semitrailer flatbed with a boom lift to a service location. While enroute, the employee encountered numerous potholes. The bumps from the potholes strained the employees back. The pain increased the next day and required medical treatment.

One near-miss incident:

- A Port labor foreman was driving a Port work truck with a passenger, heading outbound in the right turn lane at Terminal 6 (T-6). An inbound longshore foreman in a truck drove the wrong way, into the outbound right turn lane to avoid waiting at the left-turn light into T-6. The longshore worker entered with enough speed that they could not stop to prevent a collision, and swerved to their right, over a concrete island and the railroad tracks, before weaving through four lanes of traffic into the T-6 administrative parking lot. Marine security at the gate reported that this was the third driver entering this way in less than 30 minutes. Marine security leadership witnessed the event and intervened with the driver immediately afterwards.

Public Safety & Security

One non-recordable incident:

- A police officer was processing an outdoor crime scene. During the task the officer stepped on a nail that punctured their foot. Medical treatment was necessary to combat possibility for infection.

Two near-miss incidents:

- A fire fighter observed and intervened when an airport ramp service tenant truck was driving on the airfield with unsecured compressed gas cylinders (propane) in the bed.
- A fire fighter pulled out onto Marine Drive from the fire station when the vehicle lost power. It started forward but did not respond when the accelerator was pushed. The engine eventually kicked in and the vehicle moved forward normally. An oncoming semitrailer moved partly into another lane and both drivers reacted in sufficient time to avoid a severe wreck. The vehicle was pulled from fleet service.

Navigation

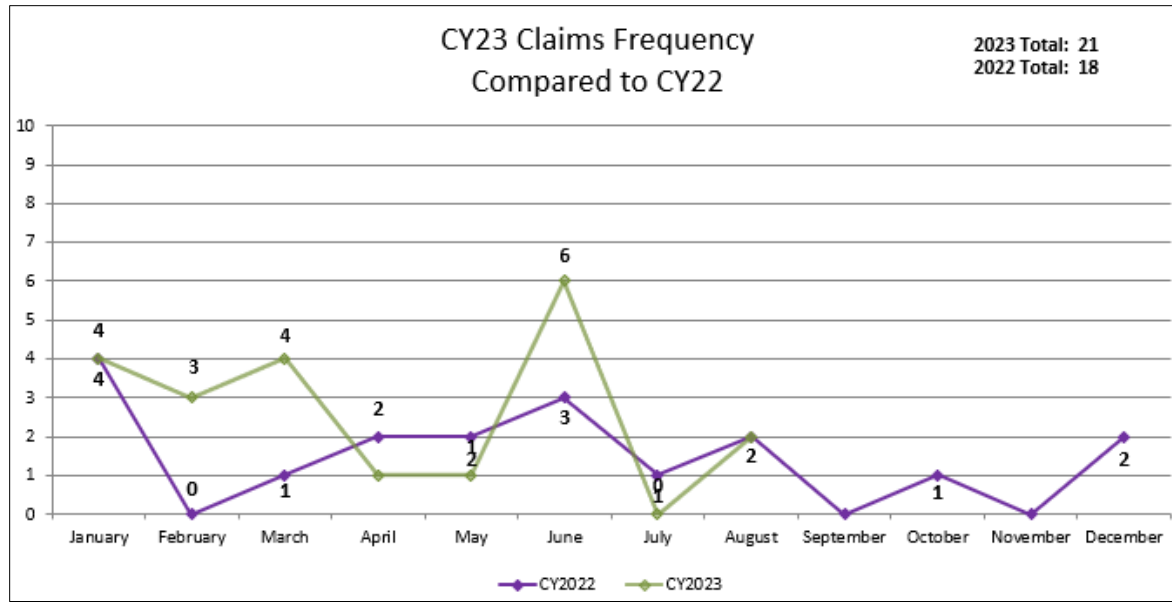
One property damage incident:

- An employee was operating a dozier at night to push logs and debris down the shore area placement site. A loose log rolled down a hill and struck the cabin door on the machine, breaking the glass. The equipment was scheduled for repair.

Headquarters

One near-miss incident:

- A man wearing no shirt arrived at the 8th floor reception lobby out of the elevators and demanded to go to the 10th floor. The receptionist deescalated the situation and persuaded the man to sit down while she called for PDX police, who responded quickly and escorted the man out of the building.
