

## OFFICIAL RULES – PDX #GoodbyeA 2019 PRIZE DRAWING

### Fly from Portland International Airport

to any Alaska Airlines, SkyWest Airlines (marketed by Alaska Airlines), or Horizon Air Destination

**By entering this prize drawing, entrants agree to be bound by these Official Rules.**

NO PURCHASE OR PAYMENT IS REQUIRED TO ENTER OR WIN. OPEN ONLY TO LEGAL RESIDENTS OF THE UNITED STATES. VOID WHERE PROHIBITED.

**Deadlines:** The #GoodbyeA 2019 Prize Drawing (the “**Drawing**”) begins at 9:00 a.m. PST on September 16, 2019, and ends at 9:00 a.m. PST on November 13, 2019 (the “**Entry Period**”). The sole determinant of time for purposes of the Drawing will be the computer clock of the Sponsor (identified below) or its service provider.

**Who May Enter:** The Drawing is open to legal residents of the United States of America who are 18 years of age or older as of the date of entry. Employees, officers, commissioners, and directors (including immediate family members of any of the preceding) of the Sponsor or of the advertising, travel, or promotional agencies thereof, and any others associated with the Drawing, are not eligible to enter. The term “immediate family members” includes spouses, parents, grandparents, siblings, children, and grandchildren. Previous winners of the Sponsor’s prize promotions within the 90 day period preceding the earliest date of the Entry Period are not eligible to win. The Drawing is void where prohibited by law.

**Contest Theme:** The Portland International Airport is getting ready to say goodbye forever to Concourse A. Opened in 1988, Concourse A was always meant to be temporary. It lasted more than 30 years and became home to crowded spaces, dim lights and stuffy vibes. But travelers have some cool memories from their time spent in Concourse A. We do, too. To bid adieu to the least favorite corner of America’s most loved airport, PDX is inviting friends and frequent flyers to share the weirdest, sweetest and most embarrassing #GoodbyeA stories they can think of.

**How to Enter:** During the Entry Period, to enter the contest, you must do three things (the “**Social Media Entry**”):

- 1) Share your favorite memory from PDX’s Concourse A on either Instagram, Twitter or Facebook using the hashtag #GoodbyeA.
- 2) Follow the Portland International Airport (@flyPDX on Twitter/Facebook or @pdxairport on Instagram) and @AlaskaAir on the social media channel you post from.
- 3) Make your post public.

No purchase or payment is required to enter or win. Limit one entry per person; multiple entries from the same person are void.

**Winner Selection and Notification:** The Sponsor will select the winner through a random drawing on November 20, 2019, from all entries received during the Entry Period. The Sponsor’s selection of a winner will be final and binding in all respects. The potential winner will be contacted within fourteen calendar days from the date of the prize drawing. The potential winner must meet all eligibility requirements set forth in these Official Rules to qualify for the prize. Entrants that do not win will not be notified.

**Odds of Winning:** Odds of winning are dependent on the number of eligible entries received.

**Prize:** One eligible winner will receive a travel voucher redeemable for two (2) tickets for any round-trip flight from PDX to any destination served by Alaska Airlines, SkyWest Airlines (marketed by Alaska Airlines), or Horizon Air (Code Share partners are not allowed). Both tickets must be booked at the same time and cannot be used separately. All travel must be booked within 12 months from the issue date of the travel voucher.

#### **Prize Terms and Conditions:**

- Travel vouchers cannot be sold, bartered, nor used as part of an online auction. Vouchers used in such a manner will become null and void.
- Redemption must occur Monday through Friday, 9:00 a.m. to 5:00 p.m. PST.
- Modifications are not permitted once an itinerary is booked.
- Travel vouchers are not transferable and become null and void upon any attempted transfer.

- Travel vouchers may contain additional terms, conditions, and restrictions.
- Travel vouchers cannot be replaced if lost or stolen.

**Additional Air Travel Prize Terms and Conditions:** Air travel redeemed with a travel voucher will be subject to all of the operator airline's then-current ticket terms, conditions, restrictions, and fees, including without limitation:

- Restrictions may apply on popular travel dates, holidays, and flights, and to certain destinations (The following black-out dates apply: NOV 15-25, 2019 and DEC 18, 2019 - JAN 2, 2020)
- Tickets are subject to availability and may not be available on all flights or all days of the week.
- Standard baggage fees may apply.
- The winner is responsible for all applicable taxes and fees, including federal and state government fees and local airport passenger facility charges. Individual travel taxes may apply.
- Tickets may contain may contain additional terms, conditions, and restrictions.
- Mileage Plan Miles cannot be earned or credited.
- First Class paid upgrades or mileage plan upgrades are allowed.

**Prize Value:** The verifiable retail value of the prize is approximately: \$525 individual and \$1,050 total. Actual value may vary based on seasonal fluctuations, booking date, and other variables. An IRS Form 1099 will be issued for prizes exceeding \$600 in value.

**To Claim Prize:** The potential winner will be required to complete and return to the Sponsor a Prize Eligibility Certificate and Acceptance Agreement (the "**Acceptance Certification**"), in substantially the form included below, within 10 days after notice of selection. All results are unofficial until the Sponsor's acceptance of the potential winner's executed Acceptance Certification. In the event of noncompliance with these Official Rules, or if the entrant cannot be contacted, or if the potential winner can or does not truthfully certify to the content of the Acceptance Certification, the prize will be forfeited, and an alternate winner will be randomly selected. Upon the Sponsor's identification and confirmation of the winner, a written travel voucher will be provided from Alaska Airlines containing specific instructions for booking the prize tickets.

**Conditions:** The Sponsor reserves the right, in its sole discretion, to: (1) cancel, suspend, and/or modify the Drawing, or any part of it, if any fraud, technical failures, or any other factor beyond the Sponsor's reasonable control impairs the integrity or proper functioning of the Drawing; (2) modify these Official Rules at any time, to waive minor entry informalities without liability, or to otherwise modify, suspend, or terminate the Drawing at any time; and (3) disqualify any individual found to be tampering with the entry process or the operation of the Drawing or to be acting in violation of these Official Rules or in a disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Drawing may be a violation of law. Should such an attempt be made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. The Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision or of any other provision. The Sponsor will not be responsible for any: (a) telephone, computer, hardware, software, programming, or interrupted or unavailable network, server or other connections, network malfunction, or other technical failures or errors, or failure to properly process entries; (b) communication disruption or other forces beyond the reasonable control of the Sponsor, including inability to access the Social Media Entry, or other disruption related to Internet traffic, virus, bug or non-authorized intervention; or (c) damage caused by computer virus or otherwise resulting to any computer from entrant's access of the Social Media Entry, whether human, mechanical, or electronic. If such malfunction, error, disruption, or damage occurs and impairs the administration, security, fairness, integrity, or proper play of the Drawing, the Sponsor may, in its sole discretion, suspend or terminate the Drawing by posting a notice at [www.pdxnext.com](http://www.pdxnext.com). If the Drawing is terminated before the end date stated above the Sponsor may, but is not obligated to, determine a winner from all potentially eligible entries received as of the termination date. Persons found tampering with or abusing any aspect of this Drawing, or whom the Sponsor believes to be causing malfunction, error, disruption, or damage will be disqualified in the Sponsor's sole discretion. The Sponsor reserves the right to void all entries made through any robotic, automatic, mechanical, programmed, or similar entry duplication method and to disqualify any individual using such a method. Entrants agree to be bound by the decisions of the Sponsor, which decisions will be final and binding in all respects.

**Legal:** By entering, entrants release and hold harmless the Sponsor and its commissioners, directors, officers, employees, and agents from any and all liability for any injuries, loss, or damages of any kind arising from or in connection with the Drawing or any prize. The Drawing is subject to all federal, state, and local laws and regulations and is void where prohibited by law. The laws of the State of Oregon will govern the Drawing. The Drawing is not intended to be construed as a contest, sweepstakes, or other prize promotion under Oregon law;

the sole act required for entry and participation is that participants submit the online entry form with the Sponsor, and no payment of anything of value, purchase of anything, or donation is required to enter or win a prize.
