[A] Rates listed are subject to year-end adjustment.

### [B] <u>Terminal Rate Types are as follows:</u>

Type I - ATC: Ticket Counters, ATI: Self-Service Kiosks

Type II - ADA: Departure Areas (Holdrooms), APL: Passenger Lounges, ATO: Ticket Offices, ATM: CU Ticket Offices

Type III - AUA: Upper Level Area, ABC: Joint Bag Claim

Type IV - ASO: Baggage Service Offices, AOM: Operations and Maintenance (lower level space)

Type V -  ${f AIA}$ : International Arrival Facility,  ${f AOB}$ : Baggage Make Up

Type VI - AIB: Inbound Baggage Road (Enclosed Baggage Road)

- [C] All airlines are invoiced by the Baggage Consortium.
- [D] The IAF fee presumes an annual utilization between 100,000 and 300,000 deplaned passengers using the IAF. This fee is a space related charge (AIA) and is trued up at the end of the fiscal year.
- [E] Port Equipment Fees are for airlines leasing preferential or exclusive space and utilizing Port equipment. Two positions are equal to one set.
