

OFFICIAL RULES – YOUR HOLIDAY SHOPPING -- DONE! AT PDX PRIZE DRAWING

\$1,000 Travel Credit with the Airline of the Winner's Choosing

By entering this drawing or accepting a prize, entrants agree to be bound by these Official Rules

NO PURCHASE OR PAYMENT IS REQUIRED TO ENTER OR WIN. OPEN ONLY TO LEGAL RESIDENTS OF THE UNITED STATES. VOID WHERE PROHIBITED BY LAW.

Deadlines: The “Your holiday shopping -- done! at PDX” Prize Drawing (the “**Drawing**”) begins at 8:00 a.m. PST on November 9, 2023 and ends at 8:00 a.m. PST on January 5, 2024 (the “**Entry Period**”). The sole determinant of time for purposes of the Drawing will be the computer clock of the Sponsor (identified below) or its service provider.

Who May Enter: The Drawing is open to legal residents of the United States of America who are 18 years of age or older as of the date of entry except as stated in this paragraph. The following are not eligible to enter to win: (1) employees, officers, commissioners, and directors of the Sponsor; (2) immediate family members of the same household of any of the foregoing (the term “immediate family” includes spouses, parents, grandparents, siblings, children, and grandchildren); (3) previous winners of the Sponsor’s prize promotions within the 90-day period preceding the earliest date of the Entry Period; and (4) any others associated with the Drawing as determined by the Sponsor.

How to Enter: Use your mobile device to scan a QR code for the Drawing posted on signage throughout the Portland International Airport (“PDX”) and follow instructions to complete and submit an entry form, and/or complete and submit an entry form at www.flypdx.com (the “**Drawing Website**”) during the Entry Period. No purchase or payment is required to enter or win. Limit one entry per person; multiple entries from the same person are void. Entrants may receive promotional e-mail messages from the Sponsor unless the “opt-out” box is checked when completing the entry form or online registration form.

Winner Selection and Notification: The Sponsor will select the winner through a random drawing on January 11, 2024, from all entries received during the Entry Period. The Sponsors’ selection of a winner shall be final and binding in all respects. The potential winner will be contacted within 14 calendar days from the date of the prize drawing. The potential winner must meet all eligibility requirements set forth in these Official Rules to qualify for the prize. Entrants that do not win will not be notified.

Odds of Winning: Odds of winning are dependent on the number of eligible entries received.

Prize: One eligible winner will be given \$1,000 in credit toward travel with an airline of the winner’s choosing which flies from and to PDX. The prize will be in one of the following forms, in the Sponsor’s sole discretion: gift card(s), gift certificate(s), or other form of gift credit issued by the designated airline. In the event the airline of winner’s choosing does not offer gift cards or equivalent gift credit, the winner will be given two (2) \$500 Visa gift cards. Prizes are not redeemable for cash.

Prize Terms and Conditions:

- Airline-issued gift cards, certificates, or other travel credits are subject to applicable airline terms and conditions.
- Visa gift cards must be used in accordance with their terms and conditions.

Prize Value: The verifiable retail value of the prize is \$1000. An IRS Form 1099 may be issued for prizes exceeding \$600 in value.

To Claim Prize: The potential winner will be required to complete and return a Prize Eligibility Certificate and Acceptance Agreement (the “**Acceptance Certification**”) in substantially the form included below, and an IRS Form W-9, within 10 calendar days after notice of selection. All results are unofficial until the Sponsor accepts the potential winner’s executed Acceptance Certification. An award letter will be emailed to the eligible winner at the email address provided when entering the drawing. In the event of noncompliance with these Official Rules, or if the entrant cannot be contacted, or if the potential winner cannot or does not truthfully certify to the content of the Acceptance Certification, the prize will be forfeited, and an alternate winner will be randomly selected. The Sponsor will provide the prize to the winner directly.

Conditions: The Sponsor reserves the right, in its sole discretion, to: (1) cancel, suspend, and/or modify the Drawing, or any part of it, if any fraud, technical failures, or any other factor beyond the Sponsor’s reasonable control impairs the integrity or proper functioning of the Drawing; (2) modify these Official Rules at any time, to waive minor entry informalities without liability, or to otherwise modify, suspend, or terminate the Drawing at any time; and (3) disqualify any individual found to be tampering with the entry process or the operation of the Drawing or to be acting in violation of these Official Rules or in a disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Drawing may be a violation of law. Should such an attempt be made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. The Sponsor’s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision or of any other provision. The Sponsor will not be responsible for any: (a) telephone, computer, hardware, software, programming, or interrupted or unavailable network, server or other connections, network malfunction, or other technical failures or errors, or failure to properly process entries; (b) communication disruption or other forces beyond the reasonable control of the Sponsors, including inability to access the Drawing Website, submit entries, or other disruption related to Internet traffic, virus, bug or non-authorized intervention; or (c) damage caused by computer virus or otherwise resulting to any computer from entrant’s access of the Drawing Website, whether human, mechanical, or electronic. If such malfunction, error, disruption, or damage occurs and impairs the administration, security, fairness, integrity, or proper play of the Drawing, the Sponsor may, in its sole discretion, suspend or terminate the Drawing by posting a notice at the Drawing Website. If the Drawing is terminated before the end date stated above the Sponsor may, but is not obligated to, determine a winner from all

potentially eligible entries received as of the termination date. Persons found tampering with or abusing any aspect of this Drawing, or whom the Sponsor believes to be causing malfunction, error, disruption, or damage will be disqualified in the Sponsor's sole discretion. The Sponsor reserves the right to void all entries made through any robotic, automatic, mechanical, programmed, or similar entry duplication method and to disqualify any individual using such a method. Entrants and winners agree to be bound by the decisions of the Sponsor in interpreting these Official Rules and administering the Drawing, which decisions will be final and binding in all respects.

Legal: By entering or accepting a prize, entrants release and hold harmless the Sponsor and its commissioners, directors, officers, employees, and agents from all liability for any injuries, loss, or damages of any kind arising from or in connection with the Drawing or any prize. The Drawing is subject to all federal, state, and local laws and regulations and is void where prohibited by law. The laws of the State of Oregon will govern the Drawing.
