Deadlines: The "Your holiday shopping -- done! at PDX" Prize Drawing (the "**Drawing**") begins at 8:00 a.m. PST on November 9, 2023 and ends at 8:00 a.m. PST on January 5, 2024 (the "**Entry Period**"). The sole determinant of time for purposes of the Drawing will be the computer clock of the Sponsor (identified below) or its service provider.
