

OFFICIAL RULES – SPRING IS IN THE AIR 2020 PRIZE DRAWING

Fly from Portland International Airport to any Icelandair Destination

By entering this prize drawing, entrants agree to be bound by these Official Rules.

NO PURCHASE OR PAYMENT IS REQUIRED TO ENTER OR WIN. OPEN ONLY TO LEGAL RESIDENTS OF THE UNITED STATES. VOID WHERE PROHIBITED.

Deadlines: The Spring is in the Air 2020 Prize Drawing (the “**Drawing**”) begins at 9:00 a.m. PST on March 9, 2020 and ends at 9:00 a.m. PST on April 26, 2020 (the “**Entry Period**”). The sole determinant of time for purposes of the Drawing will be the computer clock of the Port of Portland or its service provider.

Who May Enter: The Drawing is open to legal residents of the United States of America who are 18 years of age or older as of the date of entry. Employees, officers, commissioners, and directors (including immediate family members of any of the preceding) of the Sponsors or of the advertising, travel, or promotional agencies thereof, and any others associated with the Drawing, are not eligible to enter. The term “immediate family members” includes spouses, parents, grandparents, siblings, children, and grandchildren. Previous winners of the Sponsors’ prize promotions within the 90 day period preceding the earliest date of the Entry Period are not eligible to win. The Drawing is void where prohibited by law.

How to Enter: Complete and submit an entry form at www.flypdx.com (the “**Drawing Website**”) during the Entry Period and complete the online registration form. No purchase or payment is required to enter or win. Limit one entry per person; multiple entries from the same person are void.

Winner Selection and Notification: The Port of Portland will select the winner through a random drawing on May 27, 2020, from all entries received during the Entry Period. The Port of Portland’s selection of a winner will be final and binding in all respects. The potential winner will be contacted within fourteen calendar days from the date of the prize drawing. The potential winner must meet all eligibility requirements set forth in these Official Rules to qualify for the prize. Entrants that do not win will not be notified.

Odds of Winning: Odds of winning are dependent on the number of eligible entries received.

Prize: One eligible winner will receive two gift certificates, each valid as a payment for flights to all Icelandair destinations or as a payment for package bookings with Icelandair Holidays. Taxes and service fees are included. After ticket issue fare rules apply. The gift certificates expire on April 30, 2021.

Prize Terms and Conditions:

- Gift certificates cannot be replaced if lost or stolen.
- Air travel redeemed with a gift certificate will be subject to Icelandair’s then-current gift certificate and ticket terms, conditions, restrictions, and fees, air travel redeemed with a gift certificate is subject to the fare conditions, taxes, fees and baggage allowance of the applicable and available fare chosen by the customer during the booking and payment process at Icelandair.com. Optional service fees may apply.”

Prize Value: The verifiable retail value of the prize is \$1,000.00 USD per gift certificate (\$2,000.00 total). An IRS Form 1099 will be issued for prizes exceeding \$600 in value.

To Claim Prize: The potential winner and their travel companion will each be required to complete and return to the Port of Portland a Prize Eligibility Certificate and Acceptance Agreement (the “**Acceptance Certification**”), in substantially the form included below, within 10 days after notice of selection. All results are unofficial until the Port of Portland’s acceptance of a properly completed Acceptance Certification. In the event of noncompliance with these Official Rules, or if the entrant cannot be contacted, or if the potential winner and their travel companion can or does not truthfully certify to the content of the Acceptance Certification, the prize will be forfeited, and an alternate winner will be randomly selected. Upon the Port of Portland’s identification and confirmation of the winner, a written gift certificate will be provided from Icelandair.

Conditions: The Port of Portland reserves the right, in its sole discretion, to: (1) cancel, suspend, and/or modify the Drawing, or any part of it, if any fraud, technical failures, or any other factor beyond the Sponsors’ reasonable control impairs the integrity or proper functioning of the Drawing; (2) modify these Official Rules at any time, to waive minor entry informalities without liability, or to otherwise modify, suspend, or terminate the Drawing at any time; and (3) disqualify any individual found to be tampering with the entry process or the operation of the Drawing or to be acting in violation of these Official Rules or in a disruptive manner. Any attempt by any person

to deliberately undermine the legitimate operation of the Drawing may be a violation of law. Should such an attempt be made, the Sponsors reserve the right to seek damages from any such person to the fullest extent permitted by law. The Sponsors' failure to enforce any term of these Official Rules shall not constitute a waiver of that provision or of any other provision. The Sponsors will not be responsible for any: (a) telephone, computer, hardware, software, programming, or interrupted or unavailable network, server or other connections, network malfunction, or other technical failures or errors, or failure to properly process entries; (b) communication disruption or other forces beyond the reasonable control of the Sponsors, including inability to access the Drawing Website, or other disruption related to Internet traffic, virus, bug or non-authorized intervention; or (c) damage caused by computer virus or otherwise resulting to any computer from entrant's access of the Drawing Website, whether human, mechanical, or electronic. If such malfunction, error, disruption, or damage occurs and impairs the administration, security, fairness, integrity, or proper play of the Drawing, the Port of Portland may, in its sole discretion, suspend or terminate the Drawing by posting a notice at the Drawing Website. If the Drawing is terminated before the end date stated above the Port of Portland may, but is not obligated to, determine a winner from all potentially eligible entries received as of the termination date. Persons found tampering with or abusing any aspect of this Drawing, or whom the Port of Portland believes to be causing malfunction, error, disruption, or damage will be disqualified in the Port of Portland's sole discretion. The Port of Portland reserves the right to void all entries made through any robotic, automatic, mechanical, programmed, or similar entry duplication method and to disqualify any individual using such a method. Entrants agree to be bound by the decisions of the Sponsors, which decisions will be final and binding in all respects.

Legal: By entering, entrants release and hold harmless the Sponsors and their commissioners, directors, officers, employees, and agents from any and all liability for any injuries, loss, or damages of any kind arising from or in connection with the Drawing or any prize. The Drawing is subject to all federal, state, and local laws and regulations and is void where prohibited by law. The laws of the State of Oregon will govern the Drawing. The Drawing is not intended to be construed as a contest, sweepstakes, or other prize promotion under Oregon law; the sole act required for entry and participation is that participants submit the online entry form with the Port of Portland, and no payment of anything of value, purchase of anything, or donation is required to enter or win a prize. Any action or proceeding arising out of the Drawing will be litigated in courts located in Multnomah County, Oregon.
