OFFICIAL RULES - SPRING IS IN THE AIR 2020 PRIZE DRAWING

Fly from Portland International Airport to any Icelandair Destination

By entering this prize drawing, entrants agree to be bound by these Official Rules.

NO PURCHASE OR PAYMENT IS REQUIRED TO ENTER OR WIN. OPEN ONLY TO LEGAL RESIDENTS OF THE UNITED STATES. VOID WHERE PROHIBITED.

Deadlines: The Spring is in the Air 2020 Prize Drawing (the "**Drawing**") begins at 9:00 a.m. PST on March 9, 2020 and ends at 9:00 a.m. PST on April 26, 2020 (the "**Entry Period**"). The sole determinant of time for purposes of the Drawing will be the computer clock of the Port of Portland or its service provider.

Who May Enter: The Drawing is open to legal residents of the United States of America who are 18 years of age or older as of the date of entry.
